INCLUSION OF PHASE IV (TECHNOCITY) EXTENSION OF TECHNOPARK IN THE DISTRIBUTION LICENCE

No.KSERC/II/LP-5/2008

Dated ,Thiruvananthapuram 2nd July 2009.

PREAMBLE

Government of Kerala vide G.O.(P) No.19/99/PD dated 12th July 1999 had granted a licence for supplying electricity to various establishments within the Technopark campus exercising the powers conferred under section 19 of the Indian Electricity Rules 1956.

Extension of licence area including Technopark Phase II and Phase III was ordered by Kerala State Electricity Regulatory Commission vide order No. KSERC/II/LP-3/2007 dated 22nd May 2008.

The Chief Executive Officer of Technopark submitted an application before the Kerala State Electricity Regulatory Commission for including Technopark Phase IV expansion area at Pallipuram Village in the licence for distribution of electricity.

As directed by the Kerala State Electricity Regulatory Commission (KSERC), Technopark published a notice in English and Malayalam dailies on 22nd October 2008, indicating the boundaries of the proposed areas.

In the said notice it was made clear that the objections if any have to be submitted within 30 days from the date of the notification. But no objection was received within the stipulated time.

Copy of the application was forwarded to Government of Kerala and also to the Kerala State Electricity Board (KSEB) on 18th August 2008 for remarks.

Public hearing on the application was held at Kaniyapuram Panchayat Civil Station Hall on 15th January 2009. No objections were raised by the public during hearing.

The Government of Kerala were addressed vide letter dated 19th January 2009 of KSERC to furnish objection if any in the matter. No comments were furnished by Government of Kerala. Kerala State Electricity Board submitted their comments vide letter dated 14th January 2009.

Thus the Commission has observed all the formalities required and has given ample opportunities for the public, Government and KSEB to raise objections if any.

In exercise of powers conferred under Section 181 of electricity Act 2003 (Central Act 36 of 2003) and all others powers enabling it in this behalf the Kerala State Electricity Regulatory Commission hereby makes the following amendments to order No. KSERC/II/LP-3/2007 dated 22nd May 2008.

ORDER

Para 3 in Part II will be read as follows:

3.Area of Licence

The area of licence shall include those pieces or parcels of land acquired by M/s. Technopark in Pallipuram Village of Thiruvananthapuram Taluk, Thiruvananthapuram District. The boundaries of the area of Licence stands modified as under.

Technopark Phase I Area

North : By National Highway 47,110 KV substation of KSEB and Kerala University Campus..

South : By Attipra-Trippadapuram Road.

East : By University of Kerala.

West : By NH Bypass.

Technopark Phase II Area (86 Acres)

North : By Kulathoor-Manvila PWD Road.

South : By Kunnukuzhy- Arasumoodu PWD Road.

East : By survey Nos 180(Pt),181 (Pt) Attipra Village.

West : By Thettiyar Canal & NH Bypass.

Technopark Phase III Area(100 Acres).

North : By Attinkuzhi Road and Technopark Phase I.

South : By Kulathoor-Manvila PWD Road.

East :By Thrippadapuram-Arasumoodu Road..

West :By Thettiyar Canal.

Technopark Phase IV (469 acres)

North: Partly by Mangalapuram- Karamoodu Road, partly by survey numbers 465,534 and 535 of Melthonakkal village, partly by survey numbers 291, 292 and 293 of Veiloor village.

East: Partly by tarred Mangalapuram Panchayat Road on the north eastern periphery and survey number 520 of Melthonakkal village, partly by survey numbers 21,22,23 and 36 of Andoorkonam village. Partly by Anathachira located in Andoorkonam village, partly by Thodu(canal) flowing along the eastern periphery of the survey numbers 81,82,83,84 and 109 of Andoorkonam Village.

South: Partly by survey Nos 97,98 and 110 of Andoorkonam village, partly by tarred road in Andoorkonam village and CRPF Pallipuram Campus.

West: Partly by tarred road of Andoorkonam Village and Appolo colony on the South West. Partly by survey Nos 326,329,330,333,341, 344,345,346 and 397 of Veiloor village in the North West. Partly by survey Nos. 500,514 and 515 of Melthonakkal village. Partly by old NH and new NH. Partly by survey numbers 294 and 295 of Veiloor village.

Para 6. (xi) in Part III General Conditions will be read as follows:

6. (xi) Licensee should bear the cost of dismantling of lines, removal of poles, transformers and other equipment of other Licensees now existing in the area of licence.

Other Comments:

All other conditions of order dated 22nd May 2008 remain the same. A copy of the map showing Phase IV extension is attached.
